Coverage Policy

Home cervical and lumber traction devices are investigative for all indications. Reliable evidence does not permit conclusions concerning their (safety, effectiveness, and effect on health outcome).

Description

Traction applies pulling and/or drawing forces to the body to stretch a given part of the anatomy or to separate two or more anatomical parts. Traction is purported to treat individuals with musculoskeletal or neurological impairments of the spine, with the goal of relieving pain, relaxing muscle spasms, and decompressing spinal structures. Pain may or may not be associated with accompanying radiculopathy. The type of traction used varies and will depend on an individual's age, weight, and medical condition.

Cervical traction is employed to stretch the soft tissues of the neck and to separate the spinal joint structures in order to relieve neck pain. Constant traction results in tiring of the muscles, which is purported to widen the joint spaces and promote pain relief. Cervical traction options include free weight and/or pulley systems or mechanical motorized devices, and these often involve a head or chin sling to enhance pull in the desired direction.

Lumbar traction is used in the treatment of low back pain, often along with other treatment modalities. The traction may be applied intermittently, using a selection of several methods. It is often performed in either an outpatient setting or in a home setting over the short term. Lumbar traction is purported to widen or decompress disc spaces, unload the vertebrae (e.g., Orthotrac™ Pneumatic Vest), decrease disc protrusion and/or muscle spasm, separate the vertebrae, or lengthen and stabilize the spine.

Prior authorization is not applicable. Claims for this service are subject to retrospective review and denial of coverage, as investigative services are not eligible for reimbursement.
